GUIDELINES

Visa Application for Entry into the Republic of Mauritius

Timing: 0930 hrs. to 1130 hrs. for submission -

Collection of passport, after two working day between 1430 hrs. and 1530 hrs.

Tourist / Business Visa - Procedure

Applicants should provide the following documents along with duly filled-in application form :

- (i) **2 recent passport size photographs;**
- (ii) **photocopy of air-tickets (original must be produced on submission time);**
- (iii) **photocopy of first three and last pages of passport;**
- (iv) **proof of employment : letter from employer/company;**
- (v) **hotel bookings from Mauritius;**
- (vi) **sponsor's/ business partner's letter from Mauritius;**
- (vii) **if passport is new , old passport also to be produced;**
- (viii) **latest Bank Statement and Income Tax papers;**
- (ix) **covering letter from Business Chamber.**

And Applicants

- (i) should hold a valid passport, whose expiry date is at least 6 months beyond the date of visit;
- (ii) should hold valid return ticket;
- (iii) should have sufficient funds, normally 50 US dollars per day or equivalent, to cover expenses other than board;
- (iv) should be eligible to re-entry their country of origin. *Hotel Booking - (Lotus)*

For Airline Staff:

Procedure as above along with No Objection Certificate and Leave Certificate.

Employment: A foreigner is not allowed to work in Mauritius, unless he/she is in possession of a valid work permit issued by the Ministry of Labour & Industrial Relations, Employment and Human Resource Development, before undertaking any travel to Mauritius. Procedure are as follows:

- (i) original work permit or copy attested by the relevant Mauritius Authorities;
- (ii) letter from employer;
- (iii) copy of medical certificate attested by the Doctor : if doctor is not known to the Consulate

Validity of Visa

First entry should be within three months from the date of issue. Period granted takes effect from the date of entry into Mauritius.

FEES : VISAS ARE ISSUED GRATIS.

N.B.: A visa does not guarantee admission. The final decision to admit a passenger or refuse him leave to land rests with the Immigration Authorities after examination at the port of entry in Mauritius.
